1. **Rautamai Rural Municipality, Office of Rural Municipal Executive, Bhuttar, Udayapur, Koshi Province, Nepal** invites electronic bids from eligible bidders for the construction of **the Construction of Asphalt concrete Pavement of Murkuchi-Puwarebhanjyang sadak staronnati, Rautamai 7 & 8 (Murkuchi-Puwarebhanjyang khand)** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs 43,100,000.00**
- Minimum Work experience of similar size and nature: **at least one number of project and value of project must not less than NRs 11,500,000.00 in last 10 (Ten Years).**

2. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
3. Bidder have the option of submitting their bid electronically only. Submission of Hardcopy bid shall not be entertained. Bidders can download the bidding documents for e-submission from PPMO's Web Site www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the non-refundable fee of **NRs.5000.00** as the cost of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (PDF format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 4. Pre-bid meeting shall be held at **Rautamai Rural Municipality, Office of Rural Municipal Executive, Bhuttar, Udayapur, Koshi Province, Nepal** at **[12:00 On 2082/05/25]**.
5. Electronic bids must be submitted to the office through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00 Hours on 2082/06/09**. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00 PM, 2082/06/09** at the office of **Rautamai Rural Municipality, Office of Rural Municipal Executive, Bhuttar, Udayapur, Koshi Province, Nepal**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs. 8,31,000.00**, which shall be valid for 30 days beyond the validity period of the bid.
7. If bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in **DharaautiKhata No. 2150152396000183 Prabhu Bank, Rautamai, udayapur Branch** and submit deposit bank deposit voucher along with the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
9. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.
10. Matters not covered in this tender notice shall be in accordance with public procurement act, 2063 and public procurement regulations, 2064 and other prevailing rules and regulations of Nepal.
