 - Only eligible bidders with the following key qualifications should participate in this bidding:
 - Minimum Average Annual Construction Turnover of the best 3 years within the last 5 years;
 - Minimum Work experience of similar size and nature: at least Three number of government 15 bedded or above Hospital building project and value of each project must not less than NRs 1,47,700,000.00 in last 5 (Five Years).
- Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding
- 3. Bidder have the option of submitting their bid electronically only. Submission of Hardcopy bid shall not be entertained. Bidders can download the bidding documents for e-submission from PPMO's Web Site www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the nonrefundable fee of NRs. 10000.00 as the cost of bidding document in the Project's revenue (Rajaswa) account as specified below and the scanned copy (PDF format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. - 4. Pre-bid meeting shall be held at Rautamai Rural Municipality, Office of Rural Municipal Executive, Bhutar, Udayapur, Province No. 1, Nepal at [12:00 on 2078/07/09].
- 5. Electronic bids must be submitted to the office through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 Hours on 2078/07/30. Bids received after this deadline will be rejected.
- The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 PM, 2078/07/30 at the office of Rautamai Rural Municipality, Office of Rural Municipal Executive, Bhuttar, Udayapur, Province No. 1, Nepal. Bids must be valid for a period of 120 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 5,538,000.00, which shall be valid for 30 days beyond the validity period of the bid.
- 7. If bidder wishes to submit the Bid Security in the form of eash, the eash should be deposited in DharaautiKhata No. 2090100303000003 Rastriya Banijya Bank, Gaighat Branch and submit deposit bank deposit voucher along with the bid.
- 8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
