Electronic bids must be submitted to the office Rautamai Rural Municipality, Office of Rural Municipal Executive, Bhutar, Udayapur, Province No. 1, Nepalthrough PPMO website: <u>www.bolpatra.gov.np/egp</u>on or before 12:00 on 23-02-2020. Bids received after this deadline will be rejected. Bidders are requested to follow the electronic bid submission procedure as specified in e-GP System Operating Guideline 2073 and User manuals issued by PPMO which are available in e-GP system.
- 6. The bidswill be opened in the presence of Bidders' representatives who choose to attend at 13:00on 23-01-2020 at the office of Rautamai Rural Municipality, Office of Rural Municipal Executive, Bhutar, Udayapur, Province No. 1, Nepal. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid,amounting to a minimum of as mentioned in para 10, which shall be valid for 30 days beyond the validity period of the bid.
